

#### **Direct Disbursements**

- Make funds available to jurors immediately after a jury or trial via direct deposit or pre-paid debit card
- Avoid the time, hassle, and cost of issuing paper checks and buying postage
- Provide payees access to payment information on mobile devices
- Card option is convenient if disbursement recipients don't have a bank account, or if they want to keep court payments separate
